I hope this letter reaches you in the best of health and Imaan, Ameen.

Let us start by thanking you for your interest in Jamia Al-Hudaa. This is our 27<sup>th</sup> year of running the Jamia, by the grace of Allah (swt) and with your kind support we are progressing well Alhamdulillah. Your cooperation and support are very much appreciated.

We are pleased to inform you that **your daughter** passed the entry test and has been offered **Provisional Admission** to the **Aalimah Course** for the 2023/24 academic year. This offer is subject to a **Four Week Trial Period** during which behaviour, educational progress and settling into the unique environment will be assessed. The trial period may be extended if appropriate. This offer is also subject to the full payment of at least the first instalment of the parental contributions due before admission.

Below is a table showing the contributions for your daughter. On average, the annual cost per student is estimated between **£6,500 – £7000**. Costs in food, utilities have increased over the years along with the staff salaries in line with the national standards. As a result, Jamia has been struggling to make the shortfall of the parental contributions. This has put a great burden on the institute to the extent that loans have had to be taken to meet this shortfall and to continue with the running of Jamia.

**In addition, some of this shortfall is made up of Zakaat money that Jamia receives.**

We fully understand that some parents are not able to make up this shortfall. However, there are some parents who can contribute more or even fully the cost of one student's education. We are humbly requesting parents if they can contribute more to this noble cause. We have tried to simplify the contributions for a range of peoples' financial situations as best as we can and hope that we can work together for the betterment of our Jamia and its students.

We are also humbly requesting that you give your Zakaat and donations to Jamia. Jamia relies on your support all the time and we would ask you to encourage your friends and family to support Jamia by giving their Zakaat and donations.

Jamia's syllabus is a complete curriculum and all the books used are provided by Jamia. Therefore, students are not permitted to bring any other books to Jamia, ideas or practices which are contrary to the teachings and practices of Jamia.

Books will be distributed to all students during the first week at Jamia and therefore, it is crucial that they are paid for so that your daughter can use them straight away. Any delay to purchase books will hinder your daughter's education as they will not be given out until payment has been made. We are sure that you will support us to support your daughter's education.

Please also ensure that your daughter also brings the following stationary items:

1. Maths Sets
2. Scientific Calculator
3. English Dictionary/Thesaurus (to be bought separately)
4. 2 x Lever Arch files (English and Maths)
5. 1 x A4 ring binder
6. A4 lined paper with margins
7. Pens, Pencils, and Colouring pencils

These are required for the relevant lessons and failure to bring the relevant stationary will hinder your daughter's learning.

Items required for residential students:

1. Padlock for wardrobes
2. Superior quality plastic bowl and flat plate & hot drink mug (BPA free and Microwave safe)
3. Set of Spoon, fork, and butter knife to use during mealtimes / teatime
4. Plastic cereal containers for students to store cereal or other dry foods.

### 1.1 PARENTS/GUARDIANS

- Get to know about my daughter's life at the Jamia and support extra-curricular activities and Jamia events.
- Ensure that my daughter follows Islamic values and practices in her daily life.

The Jamia will:

- Care for your daughter and make every effort to ensure her happiness.
- Encourage your daughter to be caring and responsible towards other students and staff of all ethnic origins.
- Treat your daughter fairly and give a clear understanding of acceptable behaviour.
- Ensure that your daughter is taught and encouraged to achieve their full potential.
- Teach your daughter the Islamic Sciences/National Curriculum and offer the experience of a range of extra-curricular activities.
- Send home reports to keep you informed about your daughter's progress.

## RULES AND REGULATIONS

1. All new applicants will have to pass the admission test and all admissions will remain valid for 1 academic year only.
2. Disclosure of all previous character and conduct is necessary. Failure to do so may result in an automatic withdrawal of the applicants/student's place.
3. Whilst in Jamia Al-Hudaa all lessons must be attended except when excused by an authorised person. No one will be permitted to leave Jamia Al-Hudaa except during fixed vacations/weekends. At the end of all holidays all students must return to the Jamia on the fixed day except when extra leave is granted. However, in cases of emergency or necessity parents/guardians wishing to obtain leave for any student may contact the Head Teacher's Office for permission.
4. All Islamic ethos and regulations will have to be followed in all aspects; particularly in prayers, dress, social conduct etc.
5. To insult the trustees, teachers or any member of staff will be judged as inexcusable and any student found guilty will be liable for dismissal. Jamia Al-Hudaa reserves the right to expel any student when it deems necessary.
6. If in any event, a student has to be sent home, the parents, guardians or relatives will have to, without objection or delay, make necessary arrangements for the student to return home. Anyone expelled will have no legal remedy against Jamia Al-Hudaa.
7. Students will be liable to pay for damages they cause to the property of Jamia Al-Hudaa.
8. I understand that Jamia Al-Hudaa has CCTV on the premises and that my child's movements may be recorded for which I have no objection.
9. In the event of students being withdrawn by parents or permanently excluded at any time for whatever reason, **no refund of parental contributions will be given.**
10. I understand and accept that If I am on any category which does not cover the full cost of a student then charity funds including Zakah will be used to subsidise the cost of my child only because she is studying to complete the Aalimah course. I authorise the Principal to use the funds as appropriate and required.
11. All the above rules and regulations and any future rules/policies will apply throughout the duration my daughter studies at the Jamia.
